The CIF ASWP Sales Purchase Agreement is to be signed after the positive due diligence on the seller, if possible face to face while the Top Table Meeting in the Seller's office, if this possibility is provided for by the seller's transaction procedure. The suppliers, sellers will provide the buyers along the PPOP documents with the resolution that authorizes anyone to receive the funds in an account opened in their name, if the Seller is not the Bank Account Holder, this resolution as well as the NCNDA /IMFPA must be legalized at Seller's cost by the Ministries of Energy and Justice of the Suppliers or Seller's countries. The Seller's side commission is paid without deduction neither bank fee and or commission transfer bank charges.
